- October 2021 ONCA becomes new legislation in Ontario for all social not-for-profit clubs.
- ➤ January 19th, 2023 Elmira Golf Club Board of Directors pass the resolution regarding new ONCA legislation at the January monthly Board Meeting
- ➤ January 19th, 2023 Elmira Golf Club Board of Directors set the AGM for Thursday March 9th, 2023.
- February 15th 25th, 2023 Information regarding the AGM is emailed or mailed to the current active shareholder/member contact list.
- February 23rd, 2023 Elmira Golf Club Board of Directors set the Shareholder Special Meeting with planned announcement at the AGM.
- March 9th, 2023 AGM at Elmira Golf Club and announcement of the Special Shareholders Meeting and the information regarding ONCA to be added website on or around April 1st.
- March 15th, 2023 Ad about Notice of Special Shareholder meeting and search for shareholders posted in Elmira Maple Syrup Festival Guide via local print material available I the surrounding area.
- March 31st, 2023 Begin to send Information regarding the Special Shareholders Meeting and link to the information to updated contact list of shareholders/members.
- April 5th, 2023 Information on search for shareholders and meeting posted around Clubhouse and an e-blast sent to followers.
- May 25th Ad about Notice of Special Shareholder Meeting posted in the KW Record, Cambridge Times, Waterloo Chronicle, Woolwich Observer, Guelph Mercury, New Hamburg Independent and posted a notice at the Woolwich Senior center in Elmira.
- May to September Several notices posted in club newsletter, website, and e-blasts about Special Meeting and for those to contact who are not receiving information.
- August 26th Social media Ad about Notice of Special Meeting and search for shareholders is sent through all Elmira Golf Club social media channels and added to current news through the Elmira Golf Club website.
- ➤ September 7th Ad about Notice of Special Shareholder Meeting and search for shareholders reposted in Cambridge Times, Waterloo Chronicle, Elmira Observer, Guelph Mercury, New Hamburg Independent and on website.
- ➤ September 13th Ad about Notice of Special Shareholder Meeting and search for shareholders posted in Ontario wide in The Toronto Star
- ➤ September 20th Ad about Notice of Special Shareholder Meeting and search for shareholders posted in the KW Record
- October 11th Wednesday at 7pm Special Shareholders Meeting at Lions Hall in Elmira (sign up required / doors open at 6pm)
- > January 11th, 2024 New Articles of Continuance to operate as a not-for-profit without shares under the new name of Elmira Golf Cub were granted by the Ontario ministry.
- ➤ TBA 2024 New By-law's will be proposed by the Board and voted on by Members in 2024 at the first Members Annual General Meeting.
